Research is multi-faceted, in a sense that it affects and can inspire contexts, within or even beyond the scope of academics. As a skill, research has its own value in the field of law, as it engages stakeholders and learners to look at problems, quite differently.

A genuine question could arise as to how should we look at the field of law, when it comes to imparting actions, and creating real impact. Always it has been the case that the trajectory of applying law, is guided by the interpretation of realities that policies anticipate. Interestingly, policies could be a government's placeholder for governance, but multiple stakeholders emerge for different realities, including the problems which emanate.

As a dynamic and young generation of lawyers and law professionals are set to take the helm of affairs in the legal fraternity with time, we also have a generation of enthused policy geeks, who in their own right, in their own field, bear competence in understanding realities and providing solutions.


Although, in Indian Law, the example of **Section 45 of the Indian Evidence Act, 1872** is usually referred to, when it comes to the inclusion of **experts** in the legal system (especially in matters related to judicial governance), it has become necessary to **anticipate the potential that law and policy as two distinct fields, can bring when used together**. VLiGTA thus aims to revisit and transform policy landscapes in India and the Indo-Pacific region, with a global outlook, to expand legal innovation with policy conscious outlooks.

Legal+Policy Research Design

Legal and Policy Design as a field does not add anything new into the research fields of Technology Law & Policy directly (or for that matter, any field of law and policy). They, however, at an epistemological level, shape the way research is approached, which indirectly, yet significantly affects the future visions of thought leadership and in determining future avenues in research, especially in social sciences and law. It can work in any legal discipline, be it Online Dispute Resolution, or international investment law. For any legal field, we need to understand a few things on basic terms:

- Any field of law, has to be seen from the understanding of Soft law as well, since hortatory effects are different from the top-down means of enforcing the rule of law;
- Hard laws have a top-down effect on the enforcement of any statute, rule or regulation. However, Soft Law as a phenomenon leads to the situation, where it happens bottom-top, due to economic, political and even technological motivations advanced in a market, leading to which governments have to develop approaches to reconcile with the economic benefactors involved due to self-regulation;

It is necessary to revisit the conceptions of soft law, to estimate how they really work.

In simple terms, soft law is a field of law which studies the phenomenon of policy realities, not necessarily guided by top-down impact of laws, rules, regulations, orders, judgments and other tools of hard law, enforced, expanded and rescinded, and rather by bottom-up factors, which have a **hortatory, quasi-legal and multi-form** tendency/quality. Such phenomena for sure remain beyond those clearly defined legal categories. Examples have been illustrated in the mind map.



Our approach towards **Legal+Policy Design (hereinafter L+P Design, where Legal means L and Policy means P)**, is based on two important contours:


- We focus on creating synergy and coherence between Indian conditions and other conditions of regions and countries, based on which, we assess and developed nuanced approaches to deal with the problems in the first place;
- We tend to avoid technocratization and generalization of the tools we develop. Even if the skeletal understanding remains the same, the way it works is solely based on experiences, the way it worked, and what feedback is taken into consideration for improvements. Hence, it is suggested never to “territorialize” upon the same idea every time;

Hence, there is never a one-size-fits-all mechanism. Here are some equations we have tried to present to elaborate how law and policy relate with each other.





Indo-Pacific in Research Design

The Indo-Pacific Region, conceptually, is the successive imagination of the two ocean regions, beyond the imagination of the Asia-Pacific region, i.e., the Indian Ocean Region and the Pacific Ocean region. We at the Vidhitsu Law Institute consider the importance of this region (or region as a construct) considering the role of India and ASEAN states. For sure, India is a leading economy in the Indo-Pacific's South Asian region, and also is a member of the Quadrilateral Security Dialogue, also known as the QUAD since 2017.

The concept was the brainchild of Former Japanese Prime Minister Shinzo Abe, who in the Indian Parliament in the 2000s, had proposed this construct in domain of maritime affairs. Beyond the theories and realities of geopolitics, we consider that in the domain of law, India and the South East Asian states are at the center of the Indo-Pacific region, offering various opportunities and aspects of importance, starting from skill mobilization, technology transfer backing legal innovation, talent inclusion in various legal domains and legal design in policymaking to resilient dispute resolution and judicial systems.

Our Indo-Pacific outlook thus is shaped by five key aims:

- Cultural intelligence and strategic ingenuity in legal innovation
- Mobilizing and mainstreaming legal research & analysis opportunities in academia & industry
- Promoting and developing in-house research solutions in various legal domains, with a technology-conscious outlook
- Transforming the Information & Knowledge Economics of Legal Education and Law in the realm of Skill Mobility
- Creating and Testing Soft Solutions and Interventions to Transform Micro and Macro Facets of Judicial & Quasi-Judicial Governance and Alternative Dispute Resolution in the region

GLA's Research Vision

The research journey of Global Law Assembly begins, when it started as a project. The trajectory is traceable from the Juris En Conference on International Law, 2020 (JECIL 2020), which was organised on February 7-9, 2020, virtually by the Firm. Before JECIL 2020, the department of **Internationalism Research** was established by the members of the Firm, which led Abhivardhan making the foundation of Global Law Assembly.

The idea of Global Law Assembly became clearer when in 2020, the Indian International Law Project was started, in which the research focus was on issues related to **India's approaches to shape international legal systems, India's Indo-Pacific approach and the influence of the multipolar world order in the systems of global governance.**

We pursued the realm of international relations and geopolitics by taking a risk-centric and constructive approach to international law research.

later on, when GLA was incorporated, Internationalism Research was dissolved as GLA had already established a research directorate to conduct and develop research.

Chart 1.2: What was the students' intake % in the years 2020-22? [Research Internships]















